2024 Year in Review

 - The increases in program participation are primarily due to the Bookmobile and Lakeside High School; and
 - 10-12 ACDL personnel are involved in material purchasing.

Trustee Hamper commented that ACDL is often the first library in the County to have titles available on Overdrive.

Westlake commented that his wife's book club was able to get a book from the Geneva Library before it was available electronically.
